## **SILICON SHORES CORPORATION TERMS & CONDITIONS**

Space Rental including setup, teardown, tables and chairs: Please see Space Rental in packet if applicable.

Prices and Service Charges: All prices are subject to change without notice. All catered events require a 17% service charge. State Sales Tax of 8.25% will be added to all food, beverage, room rentals and services provided by the Lakeside Café and Shoreline Aquatic Center in accordance with California State Laws.

Deposit Policy: 50% due when booking the event; the remainder due, in full, seven days in advance of event.

Signature on the Terms & Conditions page with your estimate required in order to run the event. If there is no signature page on file, the event will be cancelled.

Payment: Cash, Check (Made payable to Silicon Shores Corporation) or Credit Card.

Guarantee: A guaranteed guest count is required 72 business hours prior to your event. If no guarantee is given at this time, the original number of guests will be considered the guaranteed number. This count is the lowest number of guests for which you will be charged.

Cancellation: 21 days prior notice is required for all cancellations to receive a full deposit refund. Between 14 to 21 Days notice, 75% will be refunded. Between 7 to 14 Days notice, 50% will be refunded and less than 7 days, no refunds will be issued. A credit on account will be available for events rescheduled or postponed given less than 7 days notice. Cancellations made 7 business days or less prior to an event will be charged the full value of the function.

Event Times: Event times as stated in the contract are considered binding in order to insure that we may successfully service subsequent events. This establishment is not responsible for reservations not honored on the day of the event, by persons booked into the "Number of Persons" portion of the agreement. ("No Shows") This establishment is not responsible for Access Passes, Boat Rides or other equipment

arrangements not utilized by attendees. This establishment is not responsible for persons booked to participate in teambuilding events that choose not to do so or do not attend the event.

Space Rental Only: Client responsible for all set up, tear down and garbage disposal (receptacles provided). Additional time billed at "published, agreed upon price" per hour.

Extra charges may be incurred on the day of the event and paid for on that day. Extra charges may include, but are not limited to: Space Rental: use of indoor/outdoor or patio rental space over contracted hours, billed at "published, agreed upon price" per hour; lack of clean up after "space rental only" event billed at \$50.00 per hour.

Catering: additional food or drink purchased day of event billed per published price.

Modifications to menu items may result in an adjusted price. We are able to provide refrigeration for special cakes brought in.

Boathouse: additional usage over allotted "access passes" or "games participants: billed per published price.

All alcoholic beverages must be purchased and consumed on premises.
